NOTICE OF FUNDING RESTRICTIONS

THE STATE OF MINNESOTA, DEPARTMENT OF NATURAL RESOURCES ("State"), is the fee title owner of a certain piece or parcel of land located in Roseau County, Minnesota, more particularly described as follows (the "Property"):

The Northeast Quarter of the Southeast Quarter (NE ¼, SE ¼) of Section Twenty-three (23), Township One Hundred Sixty-three (163) North, Range Forty-one (41) West, according to the U.S. Government Survey thereof, Roseau County, Minnesota.

AND

The Southwest Quarter of the Northwest Quarter (SW ¼, NW ¼) and the all that part of the North Half of the Southwest Quarter (N ½, SW ¼) of Section Twenty-five (25), Township One Hundred Sixty-three (163) North, Range Forty-one (41) West, Roseau County, Minnesota, lying northerly and westerly of the main channel of the Roseau River.

AND

The Southeast Quarter of the Northeast Quarter (SE ¼, NE ¼), the West Half of the Northeast Quarter (W ½, NE ¼) and all that part of the North Half of the Southeast Quarter (N ½, SE ¼) of Section Twenty-six (26), Township One Hundred Sixty-three (163) North, Range Forty-one (41) West, Roseau County, Minnesota, lying north of the Roseau River.

Notice is hereby given that the State acquired its interest in the Property with Outdoor Heritage Funds (Laws of Minnesota 2016, Ch. 172, Art. 1, Sec. 2, Subd. 5(j)), and Laws of Minnesota 2020, Ch. 104, Art. 1, Sec. 2, Subd. 10).

The State is placing this notice of record in accordance with Minnesota Statute section 97A.056, subd 15(c), to provide notice of the following:

This interest in real property shall be administered in accordance with the terms, conditions, and purposes of the grant agreement controlling the acquisition of the property. The interest in real property, or any portion of the interest in real property, shall not be sold, transferred, pledged, or otherwise disposed of or further encumbered without obtaining the prior written approval of the Lessard-Sams Outdoor Heritage Council or its successor. The ownership of the interest in real property transfers to the state if: (1) the holder of the interest in real property fails to comply with the terms and conditions of the grant agreement or accomplishment plan; or (2) restrictions are placed on the land that preclude its use for the intended purpose as specified in the appropriation.
