Suggested Action/Motion:

The Council should discuss and decide:

- 1. Proposal Selection Selection of proposals to present at the August 27 28, 2024 hearings.
- 2. Hearing format Define presentation format and structure during hearings (15 min. each)

Background:

August 27 - 28, 2024 are the scheduled dates for the Council to hear proposal presentations seeking appropriation of OHF monies available beginning July 1, 2025. 53 project proposals were received. The Council now must decide the scope and structure of the hearing days. Over the past five years, presentation length has been 15 total minutes per presentation (10-minute presentation, 5 min. of Q & A).
